She is also responsible for Static Detonation Chamber operations in Anniston, Alabama.



Ms. Jackson has over 27 years of engineering and operations experience in leading solutions for unique, challenging projects that involve cleanup and destruction of nuclear and chemical high hazard materials.

Prior to her current position, Ms. Jackson was part of the URS leadership team that won the 2012 Project Management Institute's International Project of the Year for exceptional project management performance at the Umatilla Chemical Agent Disposal Facility in Oregon. Her acceleration initiatives were instrumental in the project completing 935 days ahead of the life cycle schedule and meeting the International Chemical Weapons Convention Treaty milestone more than six months ahead of schedule.

She started her career in the nuclear industry, starting up and operating the nation's first underground geological repository in Carlsbad, New Mexico for disposal of nuclear waste. She implemented numerous improvement projects which saved millions of dollars to the U.S. Government and doubled the processing capacity of the project from 17 shipments a week to 34 shipments a week.

She is a certified Project Management Professional and is a member of the Project Management Institute.



In addition, Brian has provided support to the Blue Grass Chemical Agent Pilot Plant by testing and evaluating processing methods for overpacked chemical agent rocket warheads.



Brian has 25 years of environmental and operations experience in the mining and weapons demilitarization industries.

Brian's history within the program includes 21 years of experience, originating at the Anniston Chemical Agent Disposal facility. Brian has numerous accolades of superior safety and environmental performance from the United States Environmental Protection Agency as a top performer and the Occupational Safety and Health Administration as a Star Site under the Voluntary Protection Program.

He manages a facility that has currently operated for over 9.5 years without a recordable injury, operated for over 8 years without an environmental noncompliance and has destroyed over 1.4 million munitions.

The Academy received Best Practice recognition by DOE and was a contributing factor in obtaining both DOE approval to restart operations, and in regaining the Voluntary Protection Program Star status (VPP) lost by WIPP as a result of its two events.

He is a certified Project Management Professional and a Six Sigma Black belt.






